## Summary SYSTEMBOLAGET Purchase Plan September 2016

### WINE

#### ARGENTINA

A red 2015 Malbec blend with minimum three grape varieties from optional region (1-8 – 2,4 €); and a 2013 or 2014 Uco Valley red Malbec blend with minimum three grape varieties (6 – 9 €).

#### AUSTRALIA

A 2014 Sangiovese (min. 75 %) from optional region (2,9 – 3,6 €); and a 2015 Grenache (min. 85 %) from McLaren Vale or Barossa Valley (4,2 – 6,2 €).

#### AUSTRIA

A 2015 Grüner Veltliner from DAC Kamptal, DAC Kremstal, DAC Traisental, Wachau Federspiel, Wagram or Wien (3,6 – 4,9 €); and a 2015 Sauvignon Blanc from Südsteiermark (4,2 – 6,5 €).

#### BULGARIA

A 2015 white blend of Chardonnay and Sauvignon Blanc where neither grape is included with more than 70 % from optional region (1,4 – 1,9 €).

#### CHILE

A 2014 or 2015 organically certified Pinot Noir from optional region (2,9 – 3,6 €); and a 2013 organically certified Syrah from Aconcagua Region, Curicó, Maipo, Maule or Rapel (4,2 – 6,5 €).

#### FRANCE

AOP Bordeaux supérieur (3,6 – 4,9 €); AOP Languedoc, AOP Corbières or AOP Faugères (3,6 – 4,9 €); AOP Saint-Estèphe, AOP Pauillac, AOP Saint-Julien or AOP Margaux (4 – 6,2 €); AOP Bourgogne, AOP Coteaux Bourguignons, AOP Macon, AOP Coteaux du Lyonnais, AOP Limoux (3,1 – 3,6 €); AOP Alsace (3,6 – 4,9 €); AOP Bourgogne (8 – 13,5 €); AOP Crémant d'Alsace (2,5 – 6 €).

#### GERMANY

A 2015 Pinot noir from Pfalz or Rheinhessen (1,8 – 2,4 €); a 2015 Pinot Blanc from Pfalz (2,2 – 2,9 €); an organically certified 2015 Silvaner from Rheinhessen (3,1 – 3,6 €); and a 2015 Bag-in-box Riesling from Pfalz (6 – 8,2 €).

#### GREECE

A 2013 or 2014 red blend with minimum two grape varieties where agiorgitiko is included with min. 40% from optional PGI or PDO classified region (3,6 – 4,7 €).

#### ITALY

A red Langhe Rosso DOC blend (2,9 – 3,6 €); a red Lessona DOC or Ghemme DOCG (4,2 – 6,5 €); Nebbiolo from Langhe DOC (2,4 – 3,6 €); an organically certified Bag-in-box IGP Marche Sangiovese (5 – 6,4 €); DOC or DOSCG from Campania or Molise (3 – 3,6 €); DOC Soave Classico or DOC Soave Superiore (3 – 3,6 €).

## NEW ZEALAND

An organically certified 2015 Pinot Noir from Marlborough where at least 50 % of the wine has to be aged in oak barrels with a volume of max. 500 litres. The ageing time should be minimum 9 months (4,2 – 6,5 €).

## PORTUGAL

A 2013 or 2014 DOC Dão red blend that has been completely or partly aged in oak barrels (1,8 – 2,4 €); and a DOC Porto that has been aged on oak according to Ruby classification (2 – 2,8 €).

## ROMANIA

A 2015 red blend with Cabernet Sauvignon and Syrah where neither grape can be included with more than 75 % from optional region (1 – 1,4 €).

## SOUTH AFRICA

An organically certified 2015 WO Western Cape red blend with cabernet sauvignon and merlot (1,8 – 2,4 €); an ethically certified 2015 shiraz and viognier blend from Western Cape (2,9 – 3,6 €); and a 2013 red Bordeaux blend from WO Stellenbosch or Constantia (4,2 – 6,5 €).

## SPAIN

A 2011-2013 DOCa Rioja (2,2 – 3,2 €); a Mencia from DO Ribeira Sacra or DO Valdeorras (3,6 – 4,9 €); a Tempranillo blend from DO Ribera del Duero (4,2 – 6,5 €); a Moscatel from optional PDO or PGI within Comunidad Valenciana (1,1 – 1,4 €); and a Garnacha Blanca from DO Terra Alta (3,6 – 4,9 €).

## USA

A 2014 Pinot Noir from California (2,9 – 3,6 €); a 2014 or 2015 Cabernet Sauvignon Bag-in-box from California (5 – 6,6 €); and a 2015 Viognier from California (2,2 – 2,8 €).

## BEER

Any Country: Barley Wine between 7-12 % alc. (0,5 – 0,8 €); organic lager (0,2 – 0,4 €).  
Specified Countries: black IPA (Belgium, Denmark, Canada, Netherlands, Norway, UK, Sweden, U.S.A.) (0,5 – 0,8 €); modern lager (Belgium, Canada, Norway, UK, Sweden, U.S.A.) (0,3 – 0,5 €); stout (Belgium, Netherlands, Sweden) (0,3 – 0,7 €); mild ale (UK, Sweden) (0,4 – 0,7 €); bitter ale (UK, Sweden) (0,4 – 0,7 €); dunkelweizen (Germany, Sweden) (0,3 – 0,55 €); rauchbier lager (Germany) (0,3 – 0,8 €); land-, keller- or zwickelbier (Germany, Austria) (0,2 – 0,4 €); lager (U.S.A.) (0,2 – 0,35 €).

## SPIRITS

Absinth (France, Switzerland, Sweden) (3 – 15 €); Cognac VSOP (France) (3 – 11 €); Whiskey (Ireland) (3,5 – 6 €); Rum (Caribbean Islands or Venezuela) (1,2 – 1,9 €); Tequila Añejo (Mexico) (6 – 12 €); Single malt whiskey (Scotland) (6 – 10 €); Malt whiskey, combi-pack (Scotland) (12 - 20€); Vermouth (France, Italy, Spain) (1,6 – 2,4 €).
