<b>Type of Product:</b> <i>What type of product our client ask for.</i>	White wine
<b>Region (Classification):</b> <i>The region/classification of the product.</i>	Mendoza or its sub-regions
<b>Grapes:</b> <i>The grape composition of the product.</i>	Grape blend of at least 2 grape varieties. None of the grape varieties may exceed 55% of the grape mixture.
<b>Vintage:</b> <i>The vintage we ask for.</i>	2018
<b>Ex. Cellar Price:</b> <i>The net price we could pay per unit (not per case). Notice that we do not ask for any commission on top of this price!</i>	4,5 - 5,6 € per 750 ml Glass bottle
