WINE

ARGENTINA

A red wine that is 100 % bonarda from optional region in Argentina that has been entirely or partly aged in oak barrels or with chips or staves.

AUSTRALIA

Margaret River, Cabernet sauvignon aged for a minimum of 10 months in oak barrels; South Eastern Australia red blend with shiraz, Bag-in-Box; white wine (optional grape) with max 9,5 % alcohol from South Eastern Australia.

BULGARIA

Bordeauxblend from optional region in Bulgaria with a modern label design adapted for the Western European market.

CHILE

Pinot noir (min 85 %) from Central Valley or Southern Regions with respective sub regions; Pais and/or cinsault from Curico, Maule or Southern Regions with sub regions where all or part of the wine has to have undergone carbonic fermentation.

SOUTH AFRICA

Merlot grape blend from WO Western Cape, WIETA, Fairtrade or IMO-fair for life certified; PET red blend (cabernet sauvignon and pinotage) from WO Western Cape; mourvèdre from WO Western Cape, WIETA, Fairtrade or IMO-fair for life certified; white wine (optional grape) with max 9,5 % alcohol from WO Western Cape

URUGUAY

Tannat (min 85 %) from optional region in Uruguay

USA

Pinot noir (min 95 %) from California aged for min 4 months; organic chardonnay (min 75 %) from California; white blend from California or Washington; rosé wine with min 75 % grenache from California.

FRANCE

Organic Languedoc Cru; red blend IGP Pays d'Oc Bag-in-Box; Cheverny or Loire white blend PET; AOP Savoie white; Muscadet Bag-in-Box; IGP Pays d'Oc or Languedoc- Roussillon organic rosé; IGP Côtes de Gascogne Rosé; pinot noir Masannay or Bourgogne rosé; Couteaux du Layon sweet wine; rhubarb flavoured sparkling wine

ITALY

Organic Rosso Piceno Superiore DOC; red Cannonau di Sardegna Riserva DOC; red Barbera d'Asti Nizza DCOG; organic white Sicily; Etna Bianco DOC; Langhe DOC Rosato; Sparkling rosé wine from Trento DOC or Franciacorta DCOG; rhubarb flavored sparkling wine

SPAIN

Tempranillo DOCa Rioja; garnacha and/or carinena DOCa Priorat; organic tempranillo VdIT de Castilla or DO La Mancha; DOCa Rioja blanco; Verdejo VdIT Castilla y León Bag-in-Box; organic bobal or monastrell optional PDO or PGI in Comunidad Valenciana, Murcia or DO Manchuela; Cava semi seco; rhubarb flavoured sparkling wine

GERMANY

Riesling and müller-thurgau from Nahe or Rheinhessen; organic grauburgunder from Pfalz or Rheinhessen; riesling from Rheinhessen; rhubarb flavored sparkling wine

AUSTRIA

Riesling from Kamptal DAC Reserve; zweigelt Bag-in-Box from Niederösterreich; rhubarb flavored sparkling wine

BEER

Any Country: organic lager; gluten free lager; lager 3,6-4%; ale with brettanomyces; berliner weisse; Specified Countries: ale (New Zealand); lager (Germany / Austria); helles lager (Germany); belgo IPA (Belgium / Great Britain / Sweden / Germany / USA); mix pack craft beer (Belgium / New Zealand / Great Britain / Sweden / USA)

CIDER & MIXED DRINK

Cider from France or Great Britain max 4.5 % in a 750 ml bottle; mixed drink with exotic or tropical berries and/or fruits in 275 – 330 ml PET bottle; rhubarb flavoured sparkling wine from optional country in Europe

SPIRITS

Sake: Junmai Shu or Junmai Ginjo (Japan); Light rum (Caribbean Islands or South America); flavored (mango or coconut) white spirit – rombas (Any Country); malt whisky (Japan); malt whisky (Highlands or Speyside); kentucky straight bourbon (USA)
