<b>Grapes:</b>	A blend with atleast two of the following grape varieties: cabernet sauvignon, cabernet franc, malbec, merlot and/or petit verdot. None of these can be included with more than 80 %. No other grape varieties than these five can be included.
<b>Vintage:</b>	2021
<b>Ex. Cellar Price:</b>	3,4 - 5,3 for 2 litre bib € per 1500 ml or 2000 ml Bag-in-Box
<b>Minimum Volume (units):</b>	80000 liters (Volume Unit 1500 ml or 2000 ml Bag-in-Box)
<b>Type of Container:</b>	Bag-in-Box
<b>Container Size:</b>	1500 ml or 2000 ml
<b>Ageing:</b>	The wine must be completely or partially aged in oak barrels or with staves for a min of 6 months
<b>Sugar level (g/l):</b>	Max 5 g/l

The wine must be certified by Fairtrade or IMO-fair for Life which means that the wine must have a current Fairtrade certificate or a current certificate for Fair for Life from IMO. This must be clearly stated on the label.</li><li>2. Please provide us with copies of the following documents with your offer of the offered vintage: WS record (green card with SA Wine Industry &amp; Systems ('SAWIS'), WSB record (pink card with SAWIS terminology)</li><li>3. We will also be asking you to send us copies of your production documentation BG6/WSR1 if we are selected for launch</li><li>4. Please note that only one product per producer can be offered.</li><li>5. A guarantee of supply document should be submitted with the offer. We will provide you this document and guidance to fill it out.</li></ol>
