3. Inner bag: no aluminium as outer layer and max. 5 microns thick aluminium layer if aluminium is used as intermediate layer («technical specifications sheet» from producer of the packaging must accompany the offer)
4. Oxygen permeability of the packaging:  $\leq 2 \text{ cm}^3/\text{m}^2/24\text{timer}/1\text{atm}$  («technical specifications sheet» from producer of the packaging must accompany the offer)
5. Outer carton box with no use of metal or plastic layers
6. Only one offer per manufacturer. If more than one offer is submitted from the same manufacturer, only the lowest priced offer will be assessed for purchase, regardless of wholesaler. The packaging must be marked using the Nordic recycling icons on packaging for plastic and carton with the additional text «bag can be recycled as plastic», «box can be recycled as cardboard» or similar in English or Norwegian <https://www.grontpunkt.no/packaging-labels/>.
7. «Guarantee of supply» must accompany the offer. «Statement on responsible recruitment and decent working conditions» must accompany the offer, Purchase as for July, launch in September
