- 1. Only one offer per producer will be accepted for this reference.
- 2. The product will be launched in the Hållbart val (Sustainable choice) category. Therefore, it must meet the requirements for it (Organic or Sustainable certification, packaging with a lower climate footprint, documented traceability and social responsibility). - 3. Wieta (score A / B) and at launch marked with The Wine and Agricultural Ethical Trade Initiative of SA's (WIETA) ethical label (WIETA SEAL) in combination with the fact that it must meet existing criteria for organic wine according to current EU legislation or IPW South Africa. The control body and that the wine is organic or IPW must be clearly stated on the label.
- 4. Valid certificates proving the above must be received by Systembolaget within three (3) working days after the winner is announced.
- 5. Grape variety and designation of origin must be clearly stated on the front label.
- 6. WS record (green card with SA Wine Industry & Systems ("SAWIS") terminology).
- 7. WSB record (pink card with SAWIS terminology) .The supplier of the winning article must send in a copy of:

 Production document BG6 / WSR1 to Systembolaget.The document must at least refer to the volume of the
 winning wine that the supplier intends to deliver to Systembolaget. All production documents must be
 correctly signed and, in cases where required by South African wine production rules, stamped by SAWIS.
