Offered product at launch must be marjed with The Agricultural Ethical Trade Initiative of SA (WIETA) ethical marking (WIETA SEAL) and/or be certified by Fairtrade or IMO-fair for life as fairtrade, which means that the wine has valid Fairtrade-certificate or valid certificate for Fair for life from IMO. A marking for faritrade must in this case appear on the package.</li><li>5. A copy of the production document BG6 / WSR1 must be provided to Systembolaget if the wine is chosen. The BG6 / WSR1 document should consider the offered volume of the winning wine in the offer. All production documents must be correct, signed and be according to South AFrican rules of wine production stamped by SAWIS.</li><li>6. The following docments must be attached to offer: a signed WS record (green card with SAWIS terminology) and/or WSB record (pink card ) of SA Wine Industry &amp; Systems ("SAWIS"). The copies should show both front and back of production documents. Valid WIETA certificate or valid Fairtrade certificate or valid certificate from Fair for life from IMO.</li></ol>
